

Women Human Rights Defenders International Coalition

The WHRD IC is a resource and advocacy network for the protection and support of women human rights defenders worldwide. An international initiative created out of the international campaign on women human rights defenders launched in 2005, the Coalition calls attention to the recognition of women human rights defenders. It asserts that those advocating for women's human rights - no matter what gender or sexual orientation they claim - are in fact human rights defenders. Their gender or the nature of their work has made them the subject of attacks, requiring gender-sensitive mechanisms for their protection and support. The Coalition involves women activists as well as men who defend women's rights and lesbian, gay, bi-sexual, and transgender (LGBT) defenders and groups committed to the advancement of women's human rights and sexual rights. What is the Coalition doing?

Production of Documentation Manual

Building on the distinct analysis and description of violations against women human rights defenders developed in *Claiming Justice, Claiming Rights: A Guidebook on Women Human Rights Defenders*, this manual is intended to be a resource for defenders and organisations documenting violations related to women human rights defenders.

Monitoring Mechanism for Urgent Appeals

Members of the Coalition respond to requests for urgent appeals from women human rights defenders at risk. This initiative is intended to track the trends and patterns of the violations and facilitate a systematic, comprehensive system of responding to these appeals that meet the specific needs of women human rights defenders.

Public Education and Policy Advocacy

Coalition members undertake advocacy at the United Nations and at regional levels to support the development of constructive policies and analysis that is sensitive to women human rights defenders' concerns. The Coalition organises events to raise public awareness and draw attention towards the recognition of women human rights defenders and the legitimacy of their work.

Global Report on Women Human Rights Defenders

This project is a follow up to a survey on the situation of women human rights defenders conducted by the Coalition in 2008. It is intended to inform the Coalition's advocacy on women's human rights defenders before the UN Special Rapporteur on the Situation of Human Rights Defenders and in other fora.

Advocacy on 'Sustaining Activism' with donors

To develop a more comprehensive, multi-faceted and long-term system of support for women human rights defenders, the Coalition has begun engaging with donors to discuss both new and tested human rights approaches to sustain women human rights defenders, their organisations and movements.

***Advocacy** at regional and global levels has ensured policy development that is sensitive to women human rights defenders concerns*
